

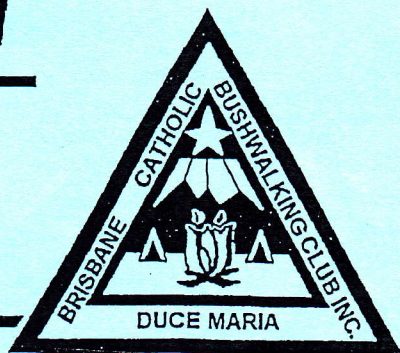

GENERAL MEETINGS

Meetings are held on the 3rd Monday of every month, at 7:30pm. The location is **St Brigid's Parish Hall, Musgrave Rd, RED HILL. VISITORS are always welcome.**

OUTINGS

- (a) Always read the Jilalan article to check the departure point, date and time.
- (b) Walk departures are usually from Red Hill Parish Hall, Musgrave Rd. Check "Jilalan" or phone the leader to determine the location.
- (c) The club will usually organise transport for each outing, but you must nominate in advance to the leader. Contacting someone else may lead to your nomination becoming "lost". Nominations should preferably be made by the Monday prior to the activity (Wednesday at the latest) so that transport etc. can be arranged. Note that nominations for some walks may close well in advance of this. Late nominations may not be accepted.
- (d) Walkers are responsible for their own transport to and from the departure point.
- (e) Walks are rarely cancelled – if they are, all nominees will be notified. Should you change your mind and decide not to come to a club event, please notify the leader as soon as possible.
- (f) **Visitors who done more than 3 walks must sign an Assumption of Risk form for insurance.**

EMERGENCY OFFICER

If, within the hour prior to an outing's departure, you can't make it or you are running late, phone the number shown in the Jilalan for the Emergency Officer for that outing. If you have not returned from an outing by 9:00pm your family may ring the Emergency Officer – but please don't panic.

EQUIPMENT HIRE

The Club has some tents and through-walk packs to hire to visitors and newer members. Borrowers are responsible for collecting and returning equipment, as well as making good any loss or damage over and above normal wear and tear. Hire rates – Packs \$10/ weekend, Tents \$5:00 – Deposit of \$20:00 required.

PERSONAL EQUIPMENT

The Association requires that all walkers on all trips should carry certain minimal basic equipment. This should comprise the following – a first aid kit, a torch, a parka/raincoat, hat, shirt 30+ sunscreen and at least 2 litres of water. Leaders may require that walkers carry other equipment. Advice of this will be given in Jilalan and/or by the leader.

MANAGEMENT COMMITTEE

All members are most welcome to attend a meeting of the Management Committee, but please contact the President beforehand. This means you can be advised of any change of date/venue. If you feel strongly about an issue, bring it along to the Committee Meeting and we'll put it on the agenda.

WARNING All persons, adult or child, member or visitor, undertake all activities of the Club at their own risk. The club is not in a position to even state that all care will be taken.

3. Fitness

1-3 Easy. Suitable for beginners

4-7 Medium. Reasonable fitness

Required

8-10 Hard. Strenuous, fit walkers only

PROPOSED CONSTITUTIONAL CHANGE TO MEMBERSHIP RULES: THE CASE AGAINST, as argued by a Life Member

As you are aware, a motion is on the table to alter the associate membership rules in the constitution of the Club. This is a contentious and potentially divisive topic, so it is very important to consider carefully both sides of the argument. To date, no one has spoken *against* the motion - and I believe the "no" case has to be stated, for all to consider. I realise it is an emotional issue and that any arguments opposing this motion may sound narrow-minded, sticking-to-the-past and offensive to people. Nevertheless, at the risk of leaving myself open to such accusations, I will attempt to put the "no" case, as I see it; I hope to state my thoughts

(fact and opinion) without offending anyone.

- The Club was established by people who were members of other clubs who felt that their particular beliefs and needs were not catered for. They held meetings to organise an alternative club and called a public meeting to determine the basics of the new club and eventually to write a constitution. The BCBC was the result.
- The founders and subsequent members felt that a club with the interests of Catholics being catered for was needed. This did not exclude others of different faiths from bushwalking, as there were three other clubs operating in Brisbane at the time of our foundation.
- What makes our club different? The word "Catholic" in the title attracts certain people; we have the annual Mass & Dinner, as well as the Barney Mass; and we have a Chaplain. We try to make it easy for members to participate in Sunday liturgies while also enjoying weekend bushwalking. We try to live our lives to a certain code and this code we bring to the Club.
- Through the years, the Club has remained a club where the "ordinary members" have been Catholics. This results in only Catholics being on committee and the Club following in the Catholic tradition- eg valuing attendance at Sunday Mass and making it possible for members to attend a Eucharistic Celebration with some part of the Catholic worshipping community either before or after daywalks and overnights or during basecamps. I do not deny that Non-Catholic members have felt excluded because of this, but most have opted to stay in the Club anyway.
- The word "Catholic" in the title selects the visitors who want to come along to this club. Those not interested will stay away. To me, this means a different sort of person is attracted to our club; our visitors and potential members are not religious fanatics but ordinary people of goodwill who are willing to give a Catholic club a go.

- The Non-Catholics who come along initially as visitors see the “Catholic” in our title and still choose to attend. Why is that? The Club over the years has retained a certain spirit and behavior different to that in other bushwalking clubs. I feel that this spirit is because the club is “Catholic”.
- There are sufficient other bushwalking clubs in Brisbane to satisfy the needs of Non-Catholics – why is there the need to change this club to accommodate? People come to this club knowing it is “Catholic” because it is in the title. They come to know us, like the spirit, like the Club and choose to stay, eventually wanting to become more involved in the running of the club – but is this reason enough to change the constitution? Fairness and equity are admirable, but there are other bushwalking clubs catering for Non-Catholics who want to serve on a Management Committee. The committee of a Catholic Bushwalking Club should be of the Catholic tradition, to retain the best of that Catholic tradition in the Club.
- The fact that some ordinary members are not practising Catholics is unfortunate, but does not require the constitution to be changed. You may have thought that some ordinary members have not even acted “Catholic” in spirit – yet again, a fault with the individual people and not the Club.
- This is not the way to revive the Club and increase membership – an “open” club will die just as a “Catholic” one can. Increasing membership requires a totally different approach – we have to be appealing to visitors, they have to want to stay, we have to be doing what we advertise we do, which is *bushwalking*. Increasing membership requires a long-term and fully participative, many-pronged attack and action.
- To increase the pool of people available to go on committee, we need to increase membership – a quick-fix constitutional change might solve it in the short term, but the club will slowly die if the whole publicity issue is not addressed.
- The proposed constitutional change does not block future changes to the constitution: that

will completely remove the “Catholic only” committee positions, that will remove the position of Chaplain, or drop the word “Catholic” in the title. The annual Mass & Dinner could just become The Dinner and the Barney Mass could become the Annual Mt Barney Walk – these changes could occur currently but the probability is lower.

- We have had a recent split in the Club, with members going off and forming an “open” club, partly because of this whole “Catholic” issue. Non-Catholics have ample opportunity to go bushwalking without altering *this* club. Catholics need not feel guilty that our associate members cannot fully participate in the administration of the Club; full participation is possible in all other aspects of the Club.

Come to the January meeting to cast your vote.

If you cannot make it, complete and post the proxy form you received in the December Jilalan. Everybody needs to have their say – this is a fundamental change to the Club.

REVIEW OF CLUB MEMBERSHIP

“The committee has been considering a review of the club’s constitution regarding the membership rules for non-Catholics. This is to bring equity to these members with respect to their participation in the club. There has been some informal discussion amongst members over recent months. At the October general meeting a working group consisting of Trev, Eliz, Michael and myself examined the club’s rules.

It is suggested that Associate Members become Ordinary Members. It will allow these members to vote and to be elected to a number of positions on the management committee. Attached is a motion presented by some members at the last meeting to certain rules and a General Meeting Decision.

All members are encouraged to consider these changes. As with all changes to the constitution, any motions will be 'on the table' for an appropriate period of time. The motion will be voted on at the January meeting.

There is also a proposal to change By Laws 01.01, 16.01 and 16.03, which relate to administrative changes to accurately reflect how activities are now currently undertaken.

That the rules relating to certain by-laws be changed to reflect the current activities within the club.

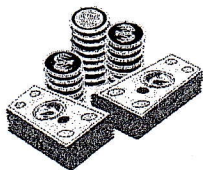

This is the cheapest daywalk offered by the club, it permits you to sleep in, and can be as short as you like. We get to walk around a very scenic area of Brisbane. What more could you ask for?

For those who don't know the Little Kings Movement is established primarily to assist the handicapped by offering vocational training, entertainment, friendship, pastoral assistance, and support. Their charter also covers helping anyone in need and lately this includes helping displaced refugees and the homeless in Brisbane.

They have a centre at Buranda and transport people there from all over Brisbane using specially modified buses. They provide meals to the disabled also etc etc. It all costs money - quite a lot in fact even though they have no paid staff - it is all voluntary.

The annual collection underpins the activities of the Movement for the whole year. Last year our club helped raised about \$1,000 for their work. We do make a difference!

It is a chance to show that our club is not just here for a good time, but we are practicing what we believe in. Our club traditionally collects in the Graceville area. Please come along for whatever time you can spare on the Sunday, and help the club show that we do care for those in need and contribute significantly to the operations of The Little Kings Movement.

If we get a lot of people we finish our allotted area more quickly and it becomes a very easy day. Any contribution of time is gratefully accepted!! Of course, we traditionally meet for lunch and coffee afterwards – a lovely way to ease into the afternoon!!

Come away for a peaceful weekend camped beside the tranquil waters of the Noosa River. We will travel to Elanda Pt and cross Lake Cootharaba by boat to pick up our canoes at Kinaba. This will make the trip a lot easier with more time to explore this amazing waterway as we canoe over Fig Tree Lake full of aquatic plants and into the channel of the upper Noosa River.

The organically dark waters reflect spectacular reflections of twisted paperbarks and bloodwoods lining the banks as we move quietly along watching out for glimpses of black swans, egrets, darters and many more species of waterbirds. We pass the entrance to Lake Como

where whistling kites and ospreys may be seen overhead. The area at Harrys Hut was once the site of a logging camp where kauris, hoop pines cypress and beech trees were cut down to be floated downstream and taken out by bullock teams. Large goannas wander around the area and move along through the vegetation beside the riverbanks.

Our campsite is up past Harrys at Camp 3 which has its own jetty to swim from and sit quietly observing the bird and wildlife at its best. Depending on the weather, we may walk up to the Cooloola Sandpatch on Sunday or canoe along the river exploring the tributaries of this beautiful waterway. We will enjoy stories around the campfire Saturday night so bring along your best tale or poem to share and look forward to a magical site later in the night.
