He is certainly remembered. Not many who died in 1937, would still have the number of visitors he has.

After leaving the grave and the contemplations it induces, the walk to the vehicles seemed long and boring. Thanks to all who came - Ed T, Bernadette, Kerry M, Brett, and Yvonne. Thanks to Anthony for the pre-outing, and to Anthony (again), Michele and Greg, for driving us down on the Friday.

BY-LAWS

## BY-LAWS of the BRISBANE CATHOLIC BUSHWALKING CLUB

BY-LAW 01.		GENERAL MEETINGS
04	00	71 0 7 14 1

The General Meeting of the Club shall be held on the third Monday of the month on the third 01.01 floor, Catholic Centre, Edward St Brisbane.

01-02 General meetings are open to visitors, Catholic or Non-Catholic.

#### BY-LAW 02. ANNUAL GENERAL MEETING

The Annual General Meeting of the Club shall be held on the third Monday in February in the same place as the February General Meeting.

#### MANAGEMENT COMMITTEE BY-LAW 03.

03.01 The Management Committee shall meet on the first Monday of the month or at such time as shall from time to time be determined by the Management Committee, pursuant to clause 17.01 of the rules.

03.02 The Management Committee shall meet in such place as shall from time to time be determined by the Management Committee.

03.03 Observers may attend a Management Committee meeting provided that a majority of Committee members agree to the observers presence at the meeting.

#### BY-LAW 04. MEMBERSHIP APPLICATION/RENEWAL

Appendix 1 shall be the form for a membership application. This same form shall be used for renewal of membership excepting that a proposer and seconder shall not be required.

#### BY-LAW 05 MEMBERSHIP SUBSCRIPTION

05.01 Ordinary Membership Subscription shall consist of two portions as follows.

05.01.01 Membership Subscription Portion 05.01.02 Magazine Subscription Portion

All membership subscriptions shall be determined to the nearest whole dollar. 05.02

05.03 Membership subscriptions (New members only) shall be progressively decreased as follows:-

January to February - Full Fees. March to April - 80% of Full Fee May to June - 60% of Full Fee July to August - 50% of Full Fee - 30% of Full Fee September to October November to December - 20% of Full Fee

Household Membership subscription shall consist of one Membership Portion per person 05.04 eligible for ordinary membership in that household and one Magazine Portion per household.

05.05 Honorary Members shall pay no subscription.

05.06 Life Members shall pay no subscription.

05.07

The Chaplain shall pay no subscription.
Associate Members shall pay one Magazine Portion. 05.08

# BY-LAW 06. 06.01 DETERMINATION OF HONORARY/LIFE MEMBERSHIP

Honorary Members shall be appointed for a specific period of time and such period shall be terminated at the first meeting of the Management Committee after the A.G.M. Any Honorary membership affected by this expiry date will be considered by the incoming management committee at this time.

06.02 The procedure for awarding Life Membership shall be:-

06.02.01 The name of the person considered eligible for Life Membership must be submitted in writing to the Management Committee by a financial member.

The submission must be in the form of a motion. 06.02.02

The Management Committee must, by a special resolution, approve of the

proposed Life Membership.

Should the Management Committee approve, they shall refer the matter to 06.02.03

the next General Meeting. At the following General Meeting the motion must be carried by means of

a special resolution.

#### BY-LAW 07. PETTY CASH

The Treasurer shall keep an amount of petty cash on hand, not exceeding twenty dollars.

BY-LAW 08. FORM OF PROXY

The form of Proxy shall be that given in Appendix 2.

## BY-LAW 09

09.01 The name of the Association's circular shall be "JILALAN".

09.02 The circular shall be published on a monthly basis for distribution to all members.

It will be the responsibility of the editor to circularise the Association's programme as 09.03 well as other items that may be of interest to members.

09.04 All Members shall each receive a copy of the circular per month, except Household Members who shall receive only copy per household per month.

#### BY-LAW 10. SPECIAL RESOLUTION

A special resolution is that defined in the Associations Incorporation Act or Regulations currently requiring a three-quarter majority.

#### BY-LAW 11. COPIES OF RULES/BY-LAWS

- 11.01 A copy of the Association's current Rules and By-laws shall be given to every new member upon acceptance of their application.
- 11.02 A copy of the Association's current Rules and By-laws shall be available to every member upon request.

#### BY-LAW 12. ACTIVITY LEADER

- 12.01 Leaders of Association activities shall be appointed by the Management Committee, subject to a General Meeting's right to set-aside such approval.
- 12.02 The Leader of any Association activity shall be considered to have been appointed under clause 05.06 of the Rules as the Manager of that particular event.
- The Leader shall only be entitled to receive remuneration for actual expenses incurred in 12.03 staging the activity.
- 12.04 The appointment of the Leader shall cease upon completion of said activity.
- 12.05 The leader of any Association activity shall have the right to refuse to accept the nomination of any person whom he believes is incapable of completing the proposed activity. within the allotted time. Provided always that any member of the Association so refused shall have the right of appeal to the Management Committee, or failing that, to a General Meeting.
- 12.06 The leader of each Association activity shall complete such records on the prescribed forms, giving the required information and including such details as may be required (eq. on walks - details of the route followed etc.) including the names of those who attended,
- and shall forward such reports, along with any monies received to the Treasurer.

  Programs of activities as arranged by the Management Committee through leaders must be adhered to. Any unauthorised departure there from must be reported by the leader to the 12.07 Management Committee.

## BY-LAW 13. 13.01 NOMINATIONS FOR ACTIVITIES

- Nominations should be made to the Leader or Outings/Social Secretary if the leader cannot be contacted.
- 13.02 Nominations should be made by the Monday before the activity so that transport etc. can be arranged.

#### BY-LAW 14. ACTIVITIES TRANSPORT

- 14.01 All activities depart from the Catholic Centre, unless otherwise notified.
- The Outings/Social Secretary in conjunction with the Leader arranges transport. 14.02
- 14.03 Members/Visitors are responsible for their own travel to and from the Catholic Center or designated point of departure.
- Members and visitors will not be permitted to attend any official activity, unless they 14.04 travel by the officially organised transport. The same transport should be used for the return journey.
- 14.05 Persons who volunteer to drive on behalf of the Association, shall not be charged the cost of said activity, subject to the digression of the Management Committee. If using their own vehicle, they shall be reimbursed costs, at a rate that shall be determined from time to time by the Management Committee.

#### BY-LAW 15. NON-CLUB ACTIVITIES

Any member wishing to announce or publicise any non-club activity at any meeting of the Association, or activity thereof, shall first obtain the approval of the Management Committee or its nominees.

#### BY-LAW 16. EQUIPMENT FOR WALKS

The minimum equipment for a walk shall be:- A first aid kit, a torch, a parka/ raincoat and at least 2 litres of water. The leader may require additional equipment to be carried.

## BY-LAW 17.

- EQUIPMENT HIRE
  The Association shall allow certain equipment, including tents and packs to be hired by 17.01 newer members and visitors participating in official activities.
- The cost of hire, deposit and late return fee shall be that determined from time to time by the Management Committee. 17.02
- 17.03 Borrowers are responsible for collecting and returning equipment, as well as making good any loss or damage over and above normal wear and tear.
- 17.04 Equipment is not available for hire for non-association activities without the express approval of the Management Committee.

#### BY-LAW 18. EMERGENCY OFFICER SYSTEM

The emergency officer system is designed to co-ordinate the departure and return of members, especially on walks. It provides the central point of contact for a walk from its departure, until its return.

- 18.01 Before a walk leaves Brisbane, the leader should contact the Emergency Officer appointed for that walk.
- 18.02 Members/Visitors who have nominated for a trip and at the last minute find that they are unable to attend or are going to be delayed must contact the Emergency Officer. Note that the Emergency Officer should only be contacted when it is too late to phone the leader, or he cannot be contacted.
- 18.03 Before leaving home, members and visitors must ensure that family/relatives/flat mates know their destination and the phone number of the Emergency Officer.
- If any delays/difficulties occur during a walk, the Leader will contact the Emergency 18.04 Officer. After 9pm family/relatives/flat mates may contact the Emergency Officer for details.
